Complimentary Consultation, we will discuss your wedding hair needs and goals along with scheduling for a practice run and the wedding day services.

Practice run for the Bride, the practice run is highly recommended, this should be done about 3 to 4 weeks prior to the wedding. Please bring any photos for inspiration. Bring any hair accessories, jewelry, veils etc. that you plan on wearing on your wedding day as well. Without this trial run we cannot guarantee your hair will come out exactly the way you would want it. The cost of this session is not included in the price of the wedding and must be paid in full at time of service.

• Bridal Hair Trial \$100

For your wedding party, please have everyone arrive with clean and completely dry hair. We strongly urge everyone to wear something that does not have to be removed over the head, it is best for everyone, including the bride, to wear something like a button up shirt or robe as to not mess up the hair style. Please have everyone arrive on time to ensure everyone is ready for the service/photos on time. We will provide all hair pins and styling products, the bride or wedding party may bring any hair decorative accessories, ornaments or flowers they would like themselves. Food and beverages are also permitted if being serviced in our salon.

Late Arrivals, If the wedding party is more than one hour late without making prior contact with us the assumption will be made that this is a no show. In this case, the client forfeits all deposits and payments and will be charged for missed services in full.

Cancellations, any cancellations must be made at least 14 days prior to the event. Any cancellations after this 14 day time period will result in the loss of the 50% deposit on said service. Cancellations made less than 72 hours before the event will not receive any refund.
